**OPENING-** The meeting was called to order by Mayor Smedley at 7:07 pm. Smedley asked the Council to review their copies of the November 12, 2020 meeting minutes and today's agenda. Copies of the agenda provided to all attendees. Mayor asked for a motion to approve the minutes from November 12, 2020 and today's agenda. Alderman Hoover motioned to approve, Alderman White seconded the motion, all voted aye.

-A. Moore presented the November 2020 court report, with \$3,542.00 in total revenue and 33 cases disposed of.

## **COMMITTEE REPORTS AND ALDERMEN'S REMARKS**

-Alderman Lawson is working on map for contacting new residents in Platte Woods. Alderman Lawson placed Christmas wreaths on the Platte Woods signs. Alderman Lawson stated that there was a tree down at a residence on Tomahawk that had been there over a month. She inquired about the dumpster and a decision was made to wait until the next ice storm before ordering the dumpster.

-Alderman Hoover provided copies of an article about the hidden financial cost of COVID and tips for the winter months for Platte Woods residents. Alderman Lawson reiterated that the commercial property on Prairie View needs to be addressed again.

-Alderman White asked about the lane markings on 72<sup>nd</sup> street. Mayor stated that he had spoken with Anthony Sands for options.

-Mayor provided an update for Park Committee, Andy, Community Service Worker was able to complete the handicap bathroom, paint the trim, repair termite damage and repair the inside of the park house. Mayor stated that a replacement will be required for Board of Zoning, Zoning Adjustment and Park Committee.

-A Moore shared the dates to file for candidacy for Platte Woods. The dates are December 15<sup>th</sup> at 8:00am thru January 19<sup>th</sup> at 5pm.

### **FINANCIAL REPORTS-**

-Alderman Hoover gave the report on the city's financial documents. Alderman Hoover stated there are no concerns with Paybills resolution, cashflow or budget vs. actual documents.

Alderman Lawson motioned to approve Paybills Resolution #12-10-20, Alderman Hoover seconded, and all voted aye.
